COVID-19 PANDEMIC PLAYER CONSENT FORM

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person to person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing, the wearing of face masks/coverings, frequent hand washing/sanitizing and have, in many locations, prohibited the congregation of groups of people.

Blue Devils Lacrosse/Moriches Youth Organization has put in place preventative measures to reduce the spread of COVID-19, however, Blue Devils Lacrosse/Moriches Youth Organization cannot guarantee that you, your child(ren) or a member of your family will not become infected with COVID-19. Further, attending Blue Devil Lacrosse/Moriches Youth Organization events could increase your risk and your child(ren)'s risk of contracting COVID-19.

I confirm that my child(ren) is not presenting any of the following symptoms of COVID-19 listed here: Fever, Shortness of Breath, Loss of Sense of Taste or Smell, Dry Cough, Runny Nose, Sore Throat. In the event my child(ren) begin(s) to display such symptoms, I will immediately notify Blue Devils Lacrosse/Moriches Youth Organization and my child(ren) will not attend a Blue Devils Lacrosse/Moriches Youth Organization event for a period of no less than fourteen (14) days from the onset of symptoms.

I confirm that my child(ren) has not travelled to a state or country with a COVID-19 positive test rate higher than ten percent (10%) over a seven day rolling average or higher than 10 per 100,000 residents tested. In the event that my child(ren) has travelled, or travels to such a place, I confirm that my child(ren) has quarantined, or will quarantine, for a period of no less than fourteen (14) days as currently required by New York State Executive Order before attending a Blue Devils Lacrosse/Moriches Youth Organization event or related tournament.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), my family and I may be exposed to or infected by COVID-19 by attending Blue Devil Lacrosse/Moriches Youth Organization events and related tournaments and that such exposure of infection may result in personal injury, illness, permanent disability, and/or death. I understand the risk of becoming exposed to or infected by COVID-19 at Blue Devil Lacrosse/Moriches Youth Organization events may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Blue Devil Lacrosse/Moriches Youth Organization employees, volunteers, and program participants and their families. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose for my child(ren) to participate in Blue Devils Lacrosse/Moriches Youth Organization activities.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself or family member (including, but not limited to, personal injury, disability, and/or death) illness, damage, loss, claim, liability, or expense (including attorney fees), of any kind, that I, my family, or child(ren) may experience or incur in connection with my child(ren)'s attendance at any Blue Devils Lacrosse/Moriches Youth Organization event or related tournament ("Claims"). On my behalf, and on behalf of my child(ren), family members and anyone acting on my behalf, I covenant not to sue, and hereby release, discharge, and hold harmless Blue Devils Lacrosse/Moriches Youth Organization, its employees, volunteers, agents, and representatives, of and

from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based upon the actions, omissions, or negligence of Blue Devils Lacrosse/Moriches Youth Organization, its employees, volunteers, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Blue Devils Lacrosse/Moriches Youth Organization program or related tournament.
